The Decision Ready Claims (DRC) Program is the fastest way to get your VA claim processed. You can get a decision on your claim in 30 days or less by working with an accredited Veterans Service Organization (VSO) or other accredited representative, or you can request a 30 day decision yourself.

Recently, Bob Stephenson one of our shipmates, used the DRC claim program to get a decision in his disability claim within 30 days. He had been told if his paperwork had been submitted through normal channels, a decision would have taken from 6 months to a year.

If you are now or later are faced with having to submit for a service connected disability, Bob asked that you contact him for some direction and suggestions on how to give yourself a better chance at success as well as doing the process in a timely manner.
